





# NHG, A\*STAR'S ETPL & SPRING COLLABORATE TO DEVELOP AND COMMERCIALISE CLINICAL INNOVATIONS

Inaugural Open Innovation Challenge in Healthcare attracts 42 submissions

The National Healthcare Group (NHG) **Centre for Medical Technologies and Innovations (CMTI)**, the Agency for Science, Technology and Research (A\*STAR) commercialisation arm **ETPL**, and **SPRING Singapore**, formed a tripartite collaboration to develop and commercialise clinical innovations. The partnership leveraged on the clinical, technical and industry expertise of the three organisations to organise the inaugural **Open Innovation Challenge in Healthcare**, which was supported by Biotech Connections Singapore (BCS).

Research institutes and local enterprises were invited to develop innovative solutions to reallife clinical problems faced by local healthcare professionals, with the aim of improving care delivery and patient outcomes. The six-month long competition attracted 42 submissions. Of these, 10 projects were selected to develop their projects further. (See Annex for the list of teams)

Teams worked closely with NHG clinicians to design practical solutions to improve patient care. Business workshops, organised by ETPL, were offered to teams keen to gain knowledge in various aspects of technology commercialisation, such as design thinking and product development, as well as business pitching and fund-raising. Early-stage teams also received corporate mentorship from corporations such as L'oreal, Merck MSD, Becton Dickinson, Philips Healthcare and Singapore-based Racer Technology, who provided valuable real-world business guidance, and practical market insights.

"Good population health – comprising physical, social and mental well-being – is a shared responsibility that must be owned by all sectors, not just public healthcare. NHG believes in forging collaborations with partners such as A\*STAR, SPRING, the Lee Kong Chian School of Medicine<sup>1</sup> and Nanyang Technological University. Together, we can leverage on industry, academic excellence and engineering expertise to develop innovative solutions to deliver better care for our population, and to empower people to better manage their health and encourage them to adopt healthier lifestyles," said Professor Lim Tock Han, Deputy Group CEO (Education & Research), NHG.

"The Open Innovation Challenge in Healthcare is a strategic initiative which catalyses technology innovations that improve the quality of healthcare. It is through collaborative public-private partnerships that we will be able to fast track novel ideas into innovative commercialisable products, and make these a reality for patients sooner," said Mr Philip Lim, CEO, ETPL.
