Nuts and Bolts of Brain Death Certification Workshop



Description

Proper certification of death has legal, social, and epidemiological significance. With the implementation of the Coroners Act 2010, there has been a need on highlighting the additional instructions on accurate completion of death certificates and psychosocial implications to patients and families. It is also a responsibility to many clinicians working in acute care hospitals where there could be unfamiliar and complicated processes of performing brain death certification.

This course is designed to update clinicians on the steps involved in brain death certification. In addition to the clinical aspects of brain death, the course also covers psychosocial and process aspects to equip the clinician with a good knowledge base in order to perform brain death certification well and understand their role in relation to the healthcare team managing potential brain dead donors and supporting the grieving families.
